



# Experian customer trial Prize Draw ("Prize Draw")

## Prize Draw Terms and Conditions

1. The promoter is Experian Limited, The Sir John Peace Building, Experian Way, NG2 Business Park, Nottingham, NG80 1ZZ ("Experian")
2. Entry is open to all residents of England, Scotland and Wales and aged 18 or over, except employees of Experian (and family members thereof) and those individuals connected with the organisation or administration of this Prize Draw.
3. No purchase or application is necessary. Entrants do not need to pay a fee or sign up to a subscription to be eligible for prize draw entry.
